Please be advised that Respondents are hereby calling you for cross examination in the above proceeding currently set for hearing January 6, 1976, in Boise, Idaho. I will be contacting you within the next few days regarding possible amendments to your statements which will eliminate the need for such cross examination. With their copies of this letter I am advising Messrs. Zizek, Cowles, Hagemann and Wise that Respondents have not called them for cross examination.
