Please excuse our delay in answering your inquiry of March 23, 1977 because of some confusion on our part. We had thought that your letter had been answered months early.

Attached you will find the detailed results of our analysis of paper bags from various Washington points to San Francisco. Generally speaking the shorter the distance between the point of origin in Washington and the off-junction of Portland, the higher the contribution. You should also make special note of the rate from Everett to San Francisco. This rate is composed of a combination rate and therefore is much higher than other similar rates which are shown.
