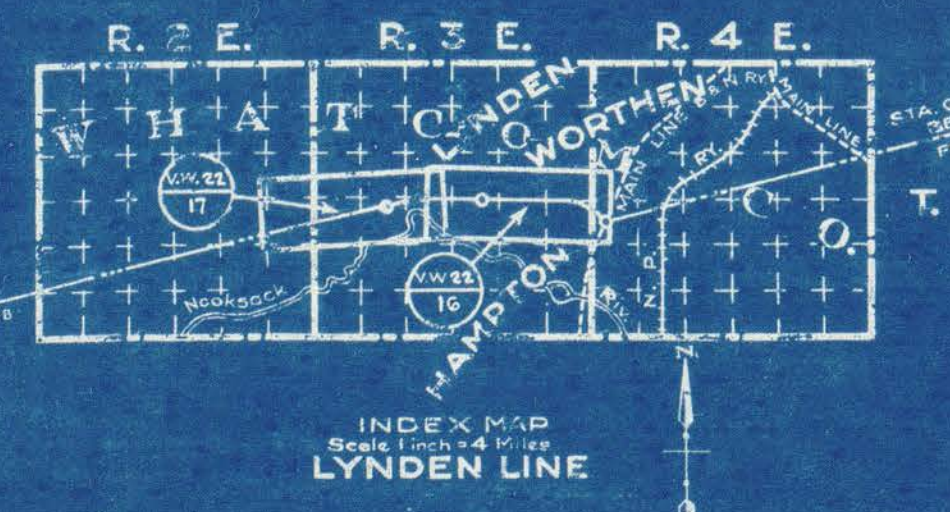


NOTE
